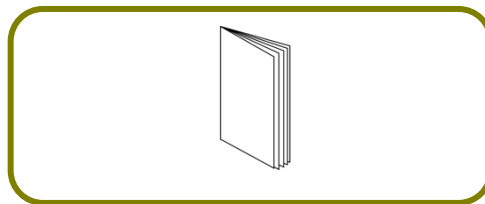
Package Content

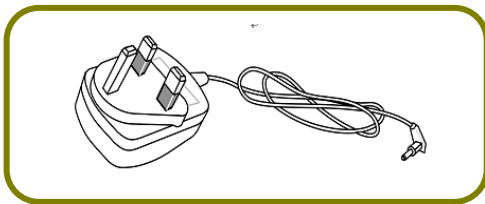

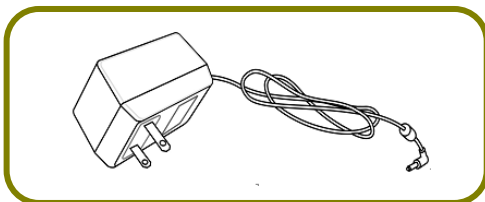

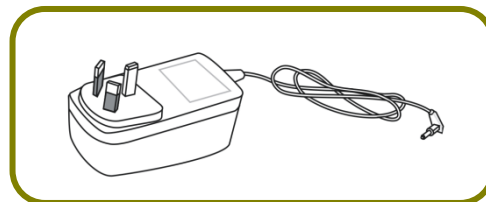
UK-type Power Adapter

USA/Taiwan-type Power Adapter

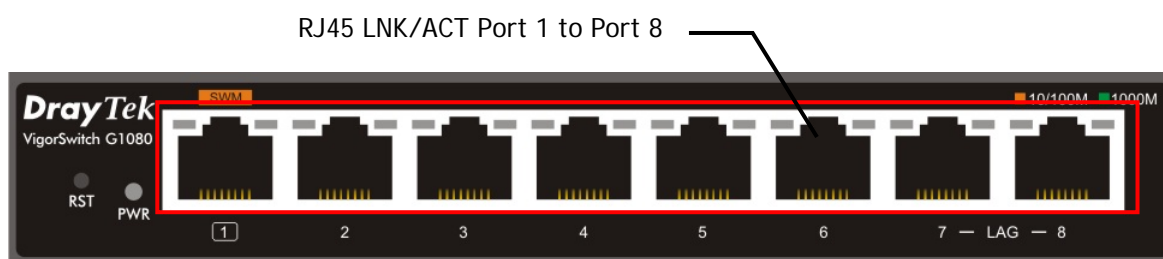

Hardware Installation

Before starting to configure the device, you have to connect your devices correctly.

A hierarchical network with minimum levels of device may reduce the timing delay between server and client station. Basically, with this approach, it will minimize the number of devices in any one path; will lower the possibility of network loop and will improve network efficiency. If more than two devices are connected in the same network, select one device as Level 1 device and connect all other devices to it at Level 2. Server/Host is recommended to connect to the Level 1 device. This is general if no VLAN or other special requirements are applied.

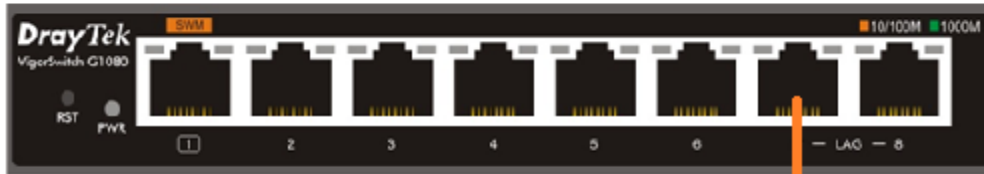
All device ports are in the same local area network.

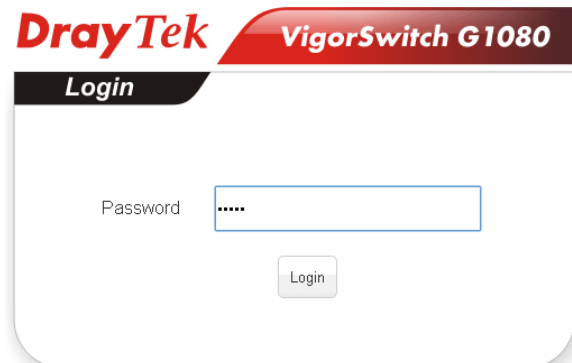
Before using the device, perform the following steps:

1. Set up a physical path between the configured the device and a PC by a qualified UTP Cat. 5e cable with RJ-45 connector.

If a PC directly connects to the device, you have to setup the same subnet mask for PC and the device. Default values of the managed device are listed as follows:

IP Address	192.168.1.224
Subnet Mask	255.255.255.0
DHCP Client	Enabled (On)
Password	admin
